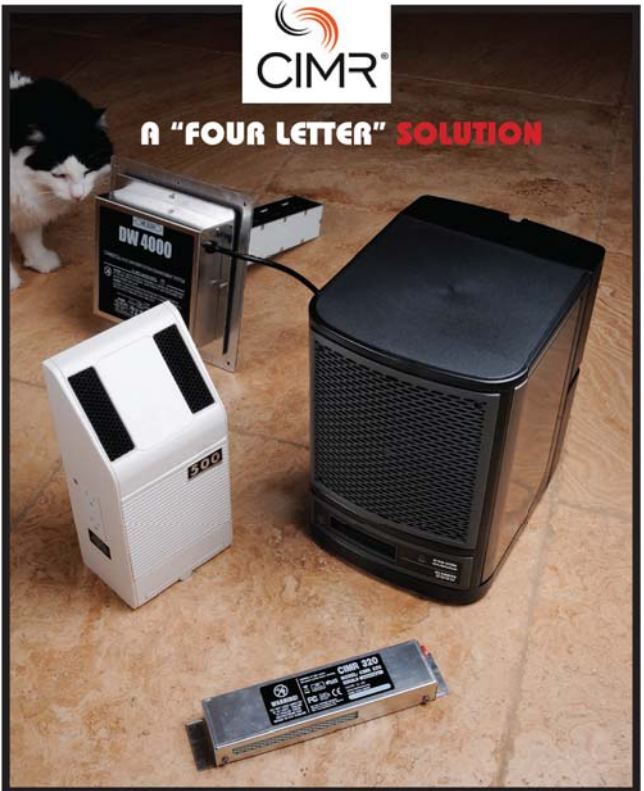

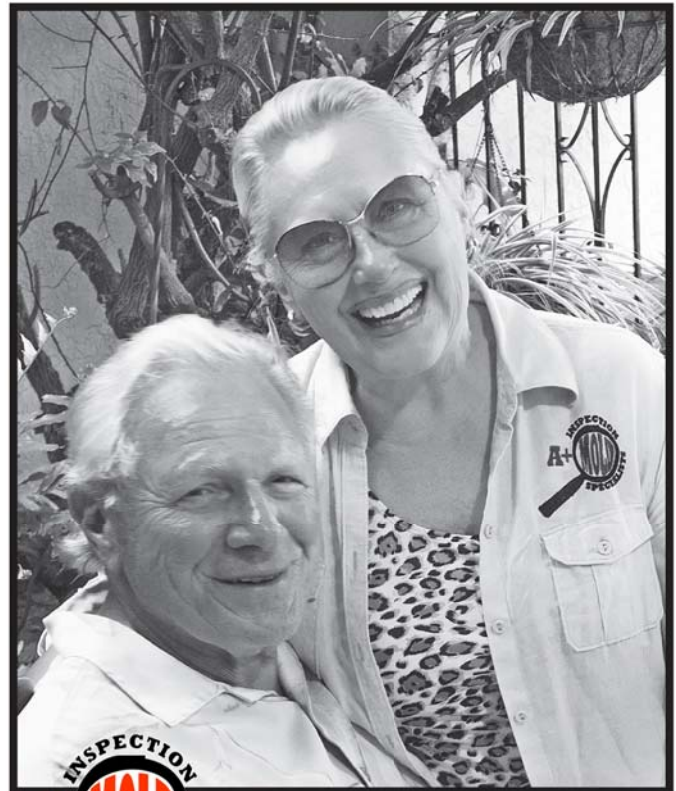


HOW DOES IT WORK ?

CIMR® Technology works by producing .02 ppm of Hydrogen Peroxide gas from the oxygen and water vapor in the air.



Hydrogen Peroxide gas is odorless and colorless, undetectable by the Human Nose. The process puts 5,000,000,000,000 Hydrogen Peroxide gas molecules in a single liter of air at room temperature. 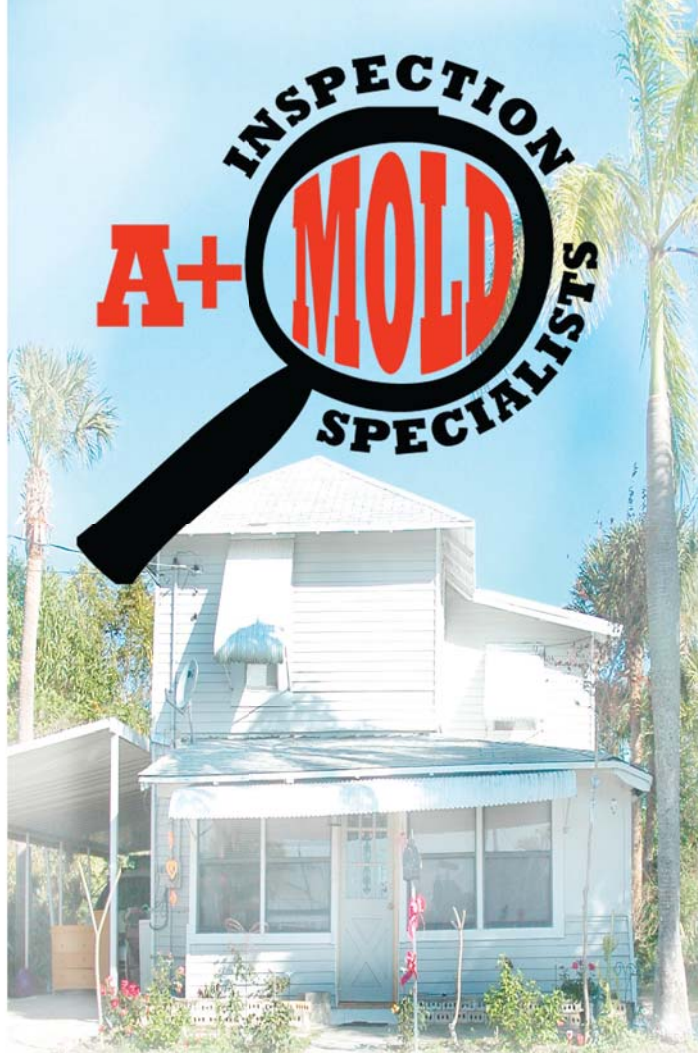
